## Instructions for preparation and submission of the final, accepted manuscript

Upon confirmation of acceptance from Kluwer, the author must send the following items to Melissa Fearon:

- 1. A **PDF** of the final manuscript, including all figures embedded in the text.
- 2. An **ELECTRONIC VERSION** (**SOURCE FILES**). Kluwer will accept almost any word processing format. Electronic figures must be embedded in the text or sent in postscript format.

NOTE: Using the journal stylefiles/templates is not required, but is preferred. They are available at <a href="http://www.wkap.nl/authors/jrnlstylefiles/">http://www.wkap.nl/authors/jrnlstylefiles/</a>. (Kluwer does not offer technical support for these style files).

## The PDF and SOURCE FILES must be sent via email to melissa.fearon@wkap.com.

- 1. Include in the email message:
  - All authors' names, postal and email addresses, and
  - ∠The journal reference code (MACH XXXX-XX)
- 2. Recommended formats for sending files via e-mail:
  - Binary files uuencode or binhex
  - Compressing files compress, pkzip or gzip

3. A signed **Consent to Publish and Transfer of Copyright Form**. It is the policy of Kluwer Academic Publishers to own the copyright of all contributions it publishes. To comply with the U.S. Copyright Law, authors are required to sign a copyright transfer form before publication. However, this form returns to authors and their employers full rights to reuse their material for their own purposes. ## **PROOFING**

After the paper has been accepted, page proofs for articles to be included in a journal issue will be sent to the contact author for proofing. The proofread copy should be received back by the Publisher within 72 hours.
